Subject: - Grant of Upgradation to Vidya Public School, New Delhi w.e.f the session 2001-2002  
from class VIII to X.

Sir,

On the subject cited above I am directed to refer your application and subsequent correspondence in connection with grant of Upgradation of Vidya Public School upto Secondary level. In this regard approval of competent authority is hereby conveyed w.e.f session 2001-2002 from class VIII to X without aid with term and condition below: -

1. The school shall abide by the provisions of Delhi School Education Act, 1973 and rules framed there under as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed as per the norms of the Department.
3. That the school shall appoint full time qualified and eligible staff as per the norms of the Department.
4. That the school shall equip the science lab as per the norms of the department and suitable facilities for practical work shall be provided to the students.
5. That proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per students shall be purchased and made available to the students.
6. That adequate sports materials shall be purchased and made available to the students immediately.
7. That the school shall strictly abide by the provisions of Delhi School Education Act and Rules 1973 and payment of salary etc. will be made as per section 10(I) of Delhi School Education Act 1973 to all the employees.
8. That the enrolment on each section shall not exceed the number of students calculated @ 10 sq. feet per student for the available floor area of the classroom and the school shall provide adequate and sufficient accommodation as per the norms of the Dte. Of Education, Delhi in each class.
9. That the school shall dispense with the service of unqualified and over aged staff if any immediately.
10. That the managing committee of the school shall not enhance the fee during the ensuing academic session without the prior approval of the Director of Education on that too as per the norms set up by Hon'able Court.
11. That the managing committee shall regulate the functioning of the school strictly in accordance with the provision of Act and Rules
12. That the service contract between the management and the employee shall be executed immediately.
13. That fresh health certificate may be obtained from the NDMC and be submitted to concerned Education Officer for verification.
14. That the staff should be paid full salary through cheques from the date of opening of the school and the proof should be shown to this office.
15. That proof of appointment of staff as per recruitment rules approved by Department be shown to concerned E.O. for verifications

16. That medical facilities/leave, LTC, Bonus/CPF etc be paid as per Department rules to the staff from the date of recognition.
17. That PF register be maintained and cash book be completed and shown to the E.O. of concerned Zone for verification from time to time.
18. That the copies of the appointment letters issued to the staff be submitted to the E.O. for verification etc.
19. That proper facilities for drinking water, toilets and first aid be made upto the satisfaction of Departmental authorities. Separate toilets for boys, girls as well as for ladies and gents staff be also provided.
20. Management will run only Educational Activities in the premises.
21. That the reserve fund shall be created in the schedule bank with amount equivalent to the three months salary of the staff.
22. That report about the fulfillment of the conditions of recognition and above conditions giving the extent to which each condition is fulfilled shall be sent to the Zonal Authorities every six months.
